# DAWN conducts Exposure Visit to Baguio by Mary Joy E. Barcelona

Development Action for Women Network - Multi-Purpose Cooperative (DAWN-MPC) in partnership with Voice-PH conducts an exposure visit to Baguio on January 11, 2020.

With this partnership, DAWN-MPC was able to explore Baguio, one of the places in the Philippines that sustains the handloom weaving tradition.

The exposure trip serve as a learning experience in discovering more about the handloom weaving industry and as an inspiration in creating authentic designs that reflects Philippine Culture.

DAWN-MPC members were able to visit Narda's Handwoven Arts and Crafts Store, one of the known handloom weaving store in Baguio. The store was founded by Narda Capuyan, who started weaving Philippine blankets from recycled acrylic yarns in La Trinidad, Benguet in 1972.

Members were able to see various products from Narda's Handwoven Arts and Crafts such as clothing, bags, scarves, and other items as inspiration in creating future SIKHAY products. They also tried out their handloom weaving machines.

The members were able to explore other famous attractions in Baguio, Benguet such as; Valley of Colors "Colors of StoBoSa" in La Trinidad, Benguet; Lourdes Grotto in Dominican Hill Road, Baguio; Baguio Botanical Garden; La Trinindad Strawberry Farm; Bell Church in La Trinidad, Benguet; The Mansion in Baguio-Bua-Itogon Road, Baguio; and Mines View Park in Gibraltar Road, Baguio.



She is the founder of Project 189, an organization focusing on the promotion and protection of migrant workers with a specialized focus on migrant women in the Gulf. On 2018 she was selected as a Spark of Hope - an initiative by The Elders founded by Nelson Mandela - as one of 100 grassroots organisations that work to promote hope and justice among the most vulnerable communities in the world.

Laliebeth Petancio has a Masters degree in Mathematics; a teacher by profession who has taught at the tertiary level for more than 15 years at the Bukidnon State University in Mindanao. During the peak of the COVID-19 pandemic, she initiated and launched a volunteer group (Tawid Covid Correspondents-Abu Dhabi) to respond to compatriots plight for relief due to no work, no salary, termination from jobs and related pandemic challenges. The relief initiative goes even to Philippines to extend help to sick kids of OFVs.














Dr. Jerry Jurisprudencia discusses the impact of the COVID-19 virus to migrant women workers and returnees



- Absence of human rights and legal protection since they are considered WORKERS and are not protected laws;
- The nature of domestic work makes them vulnerable to all forms of abuse, exploitation as well as sexual violence;

# DAWN 2020 YEAR-END Report by Mary Joy E. Barcelona and Masako Ono

Despite the COVID-19 faced by our country in general in the year 2020, there were still a lot of things to be thankful for. We were able to overcome the obstacles with the new normal set-up. We are grateful for the hard working women and youth of DAWN for their commitment in the realization of our vision for women migrant returnees.

DAWN on February 18, 2020, celebrated its 24th year with the theme: "Women and Youth as DAWN's Advocates." This is in line with our commitment to continue empowering women migrant returnees and the youth so that they may inspire others as they transform from being victims to survivors to advocates. DAWN continues to provide a holistic approach to the interventions for women and youth through the following:

### SOCIAL SERVICES PROGRAM (SSP)

The DAWN Social Services Program continues to be the entry point for women and children/youth members of DAWN. Intake interviews and DAWN orientation were conducted to prospective members for them to learn about the programs and services being provided.

DAWN's caseloads as of December 2020 are the following: 28 women and 38 children/ youth.

Most of the women were referred by the Embassy of Japan to DAWN. Out of the 28 women, two (2) graduated from college, eight (8) reached the college level, nine (9) graduated from high school, two (2) reached high school level, two (2) graduated in elementary while five (5) completed a vocational course. 93% of women come from the National Capital Region and 7% come from as far as Region IV. Economically, ten (10) women are self-employed, eleven (11) are employed while seven (7) women are being supported by their grown-up children/ partner/husband and unemployed.

From the 38 children/youth members of DAWN, twenty (21) are female, and seventeen (17) are male. As for their educational level, one (1) completed his Residency Training on Internal Medicine on December 11, 2020 at UP-PGH, one (1) taking her masteral degree, five (5)

are college graduates and now working, five (5) are in college, four (4) are senior high graduates, six (6) in Grade 11 & 12, eight (8) in Grade 7-10, five (5) in elementary and three (3) NOSA.

### Counseling and Life Coaching

DAWN regularly provides counseling and life coaching with feminist perspective to women migrant returnees and their children who are in their youth through group work activities and individual sessions. This brings about their empowerment, self-awareness, self-confidence and personality development. We would like to acknowledge all our partners who were in one way or another been part of the life coaching and collaborative activities provided for the women and youth.

Among the conducted life coaching activities for 2020 are the following:

- Stress Management & Skills Development (September 12, 2020)
- Strengths, Weaknesses and Motivation (September 19, 2020)
- Leadership and Decision-Making Skills (September 26, 2020)
- Values Clarification (October 03, 2020)

## ALTERNATIVE LIVELIHOOD PROGRAM (ALP) – Sikap-Buhay (SIKHAY)

Aside from providing social services to women migrant returnees and their families, DAWN also provides economic interventions through the Alternative Livelihood Program's SIKAP BUHAY (Sikhay), which means Striving for Better Life. Regular assessment and planning meetings are being held to discuss the center-based projects (sewing and handloom weaving). For 2020, three (3) regular members were part of SIKHAY.

Eight (8) home-based projects were assisted among them are: two (2) sari-sari stores; two (2) massage services; one (1) food services; one (1) sewing project; one (1) buy & sell (t-shirt designing); and one (1) peanut butter making. Capability building trainings are provided for the women to continuously equip them with the appropriate skills for the projects.

Currently, the women of Sikhay are able to produce more products with better designs that they can market and sell, bringing about potential increase in sales addressing the women's condition towards economic empowerment.

The following partners supported Sikhay in selling its products: Aki Ning Maisog or the Children of Maisog Enterprise, Inc. which is located at NAIA Terminal 3, Unilab-BIOFEMME annual event, Peace Boat, JICHIRO annual meeting, exhibited by Mr. Akihiro Tamura, DAWN-Japan volunteer, Chiba University-CVP students; YUMEUTA, Global NARUNIA and its regular showroom at DAWN office.

Department of Trade and Industry (DTI) Kapatid Mentor Micro-Enterprise (KMME) Training led to pivoting SIKHAY into masks making and opportunity to sell SIKHAY handwoven washable face mask at DTI Metro Fiesta – online selling event on Dec 2-13, 2020.

Through DAWN, the women are able to tap resources from government agencies that are mandated to provide assistance to returning migrant workers.

In this aspect, the women become aware of the services they are entitled to from the different government agencies. They are able to claim the benefits that returning Filipino workers are entitled to enjoy.

### DAWN - MULTI-PURPOSE COOPERATIVE (MPC)

In line with the grant in 2019 by the Voice-PH, by the Ministry of Foreign Affairs of the Netherlands and managed in consortium by Oxfam Novid and Hivos, conducted the Forum on Women Migrant Concerns, with the theme "Empowering Women Through Cooperative" was held at The Bayleaf Intramuros Manila on February 1, 2020.

This event attended by 36 guests from the academe, NGOs, private sectors, and migrants and their families. DAWN's Women (Gilda & Zenaida) shared their stories of "Life After Working Abroad." DAWN's Youth (Masako, Eien, and Mitzie) shared their life in "Encountering Challenges & Empowering the Youth." Speakers talked about "Emerging Economic Opportunities for Migrant Returnees," "Issues and Concerns of Women Migrant Workers," and "Health is Wealth: Women's Self-care." There were also inspirational messages from partners and mentors. Members were empowered and inspired realizing the importance of support system and the impact of DAWN-MPC in the lives of migrant returnees and members of their families.

## RESEARCH, EDUCATION AND ADVOCACY PROGRAM (REAP)

To provide heightened awareness on the issues of women migrant returnees and their families, DAWN continues its efforts to collaborate with various media partners as well as maintain its presence through its existing media platforms, media mileage, tri-media guesting and interviews and newsletters and lobbying for pro-women and pro-OFW laws and policies is one collaboration that DAWN does whole year round with network partners locally and internationally.

DAWN utilizes theater for women and children to express themselves and as an advocacy tool, thus making Teatro Akebono a legitimate theater advocacy group. It presents stories about the plight of women migrant workers and their families.

Theater acting allows the women and their children to express themselves in a creative way, thus becoming therapeutic for them. The women and children through creative collaboration in theater advocacy makes them co-advocates of migrant workers' rights making Teatro Akebono a unique approach in the healing process. Due to the pandemic, the yearly presentation of "The Crane Dog" has been postponed.

"REGALO" is another advocacy campaign theater play of DAWN's Teatro Akebono performed by the women and the children/youth. The story is about the cycle of migration from home country - transit - country of destination and upon return. It shows the push and pull factors of migration being dealt by migrant workers in Japan, the realities while they are abroad and its social cost.

The challenges upon return in our homeland and the stigma, identity, abandonment and recognition attached to the children (Japanese-Filipino Children) and the women themselves.

The significant role of civil society organizations (CSOs), non-government organization (NGOs) and government organizations (GOs) for returned women migrants creating a huge impact in the women's empowerment.

The song and choreography is a collaborative effort from the women and children themselves. It was performed during the DAWN-MPC Forum on Women Migrant Concerns on February 1, 2020 held at The Bayleaf Intramuros, Manila.

DAWN partners with Rights Corridor, an online portal containing researches, policies and articles on migration in Asia and the Gulf Regions. Together, they launched Rights Corridor on February 27, 2020 at the Sheraton Manila Bay. DAWN Executive Director Carmelita Nuqui gave the opening remarks discussing the migration scenario in the region and how Rights Corridor may help in promoting the rights of migrants.

To jumpstart the celebration of Women's Month, DAWN was part of the launch of the EU Gender Champion last March 2, 2020 at the Austrian Residence in Makati.

The EU Gender Champion, Ambassador Bita Rasoulian of Austria, presented the European Union's commitment to Gender Equality and Women Empowerment in the Philippines. DAWN looks forward to a fruitful partnership with EU in promoting the welfare of women migrants and members of their families.

The webinar series from October 14 to December 9, 2020 were all held in partnership with the British Embassy Manila (BEM).


